RULES - Entries Close August 1st

1. IAFE Code of Show Ring ethics will apply.
2. All entries must be in place Monday 4:00pm.
3. Bedding will be supplied by the fairgrounds. Pens MUST be cleaned daily.
4. Gilts may only show in one division. (ex. Breeding Gilts or Market Hogs) Not Both.
5. All decisions are at the discretion of the show committee.
6. NO tents will be allowed around barn area.
7. All exhibitors must wash out and remove all manure from wash pens after each use.
8. NEW THIS YEAR: All open exhibitors are responsible for weighing their own market class entries. There will be a 15lb weigh back. Weight cards will be available at the weigh in station. All weight cards must be turned into the livestock office by 6:00pm Monday evening. If you have any questions regarding this procedure, please see a committee member and they will assist you.
9. New This Year: All open exhibitors are responsible for having their hog's entry id number clearly printed on both sides of the hog. Paint branding irons will be available Tuesday for exhibitors to use. If you have any questions regarding this procedure, please see a committee member and they will assist you.

1. Market Hog Class
 - All Swine in this class must submit weight cards to the livestock office by 6:30pm Monday.
 - Classes will be divided by weight. (Light, Medium, Heavy).
 - All market hogs must be born after Jan 1st of the current year.
 - Awards: Banner – Overall Champion Market Hog
Banner -Reserve Champion Market Hog
 2. Breeding Gilt Class
 - All gilts will be shown by age. Gilts must be born after Jan 1st of current year.
 - Open to both purebred and crossbred gilts.
 - Birth dates must be clearly printed on the entry form.
 - Awards: Banner – Overall Champion Breeding Gilt
Banner - Reserve Champion Breeding Gilt
 3. Bred & Owned
 - All entries must have been bred by the exhibitor.
 - Classes will be determined based on entries.
 4. Pen of 3 Market Hogs
 - All nominated hogs must be owned by one exhibitor.
 - All nominated hogs must have showed in the market class.
 - Entries will be judged in the barn after the show.
 5. Pen of 3 Breeding Gilts
 - All nominated hogs must be owned by one exhibitor.
 - All nominated hogs must have showed in the breeding gilt class.
 - Entries will be judged in the barn after the show.

- Exhibitor age will be as of Jan 1st of current year.
 - Age must be clearly printed on entry form.**
