



Dutchess County Fairgrounds Seasonal Food Concessions Operations

Thank you for your interest in joining us at the Dutchess County Fairgrounds. The Dutchess County Fairgrounds hosts over 20 events each season in addition to the Dutchess County Fair. Our events range from antique cars to crafts, from agricultural to antiques and the Country's largest Sheep & Wool festival.

Seasonal Food Concessions are chosen on concession application and support materials, menu, concessions experience, booth presentation and location availability. Typically, concessions are selected to join us in January. There are very few openings and the selection process is very competitive.

Incomplete applications will not be considered. Applications will be acknowledged with a confirmation of receipt letter. Concession License applications are available at www.dutchessfair.com.

Concessionaires' rental fees are 20% of gross sales after applicable sales tax, unless located in a DCAS facility. Vendors not participating as a food concession in the Dutchess County Fair pay a \$150 non-refundable deposit for each event. The deposit will be credited toward the vendor's percentage payment.

Some of the season shows require concessions to purchase their products from approved Fairground's purveyors.

When booked, Seasonal Food Concessionaires must submit;

- Proof of NYS Disability
- Proof of Workmans' Comp coverage
- Proof of Vehicle insurance
- Valid certificate from the Dutchess County Department of Health
- Food Safety Certification
- Certificate of liability insurance naming the Dutchess County Agricultural Society, Inc and the Dutchess County Fairgrounds as additional insured for at least \$1,000,000.

License fees are subject to change and do not include tent rentals and other extraordinary costs. Limited on-site camp sites and on-site storage are available at an additional charge on a first come first served basis.
